

SUMMARY ANNUAL REPORT FOR

UNITED ASSOCIATION LOCAL NO. 7 WELFARE FUND

THIS IS A SUMMARY OF THE ANNUAL REPORT FOR THE UNITED ASSOCIATION LOCAL NO. 7 WELFARE FUND, (EMPLOYER IDENTIFICATION NO. 14-6029930, PLAN NO. 501) FOR THE PERIOD JUNE 1, 2019 TO MAY 31, 2020. THE ANNUAL REPORT HAS BEEN FILED WITH THE EMPLOYEE BENEFITS SECURITY ADMINISTRATION, AS REQUIRED UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974 (ERISA).

THE VALUE OF PLAN ASSETS, AFTER SUBTRACTING LIABILITIES OF THE PLAN, WAS \$73,416,188 AS OF MAY 31, 2020 COMPARE TO \$70,820,848 AS OF JUNE 1, 2019. DURING THE PLAN YEAR THE PLAN EXPERIENCED AN INCREASE IN ITS ASSETS OF \$2,595,340. THIS INCREASE INCLUDES UNREALIZED APPRECIATION OR DEPRECIATION IN THE VALUE OF PLAN ASSETS; THAT IS, THE DIFFERENCE BETWEEN THE VALUE OF THE PLAN'S ASSETS AT THE END OF THE YEAR AND THE VALUE OF THE ASSETS AT THE BEGINNING OF THE YEAR, OR THE COST OF ASSETS ACQUIRED DURING THE YEAR. DURING THE PLAN YEAR, THE PLAN HAD TOTAL INCOME OF \$15,763,573. THIS INCOME INCLUDED EMPLOYER CONTRIBUTIONS OF \$12,857,341, EMPLOYEE CONTRIBUTIONS OF \$674,041, REALIZED GAINS OF \$74,662 FROM THE SALE OF ASSETS AND EARNINGS FROM INVESTMENTS OF \$1,898,113. PLAN EXPENSES WERE \$13,168,233. THESE EXPENSES INCLUDED \$642,991 IN ADMINISTRATIVE EXPENSES AND \$12,525,242 IN BENEFITS PAID TO PARTICIPANTS AND BENEFICIARIES.
