

SUMMARY ANNUAL REPORT FOR

UNITED ASSOCIATION LOCAL 7 PENSION PLAN

THIS IS A SUMMARY OF THE ANNUAL REPORT FOR THE UNITED ASSOCIATION LOCAL 7 PENSION PLAN, (EMPLOYER IDENTIFICATION NO. 91-2055384, PLAN NO. 001) FOR THE PERIOD JUNE 1, 2021 TO MAY 31, 2022. THE ANNUAL REPORT HAS BEEN FILED WITH THE EMPLOYEE BENEFITS SECURITY ADMINISTRATION, AS REQUIRED UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974 (ERISA).

BASIC FINANCIAL STATEMENT

BENEFITS UNDER THE PLAN ARE PROVIDED BY A TRUST (BENEFITS ARE PROVIDED IN WHOLE FROM TRUST FUNDS). PLAN EXPENSES WERE \$15,274,527. THESE EXPENSES INCLUDED \$1,050,372 IN ADMINISTRATIVE EXPENSES AND \$14,224,155 IN BENEFITS PAID TO PARTICIPANTS AND BENEFICIARIES. A TOTAL OF 1,429 PERSONS WERE PARTICIPANTS IN OR BENEFICIARIES OF THE PLAN AT THE END OF THE PLAN YEAR, ALTHOUGH NOT ALL OF THESE PERSONS HAD YET EARNED THE RIGHT TO RECEIVE BENEFITS.

THE VALUE OF PLAN ASSETS, AFTER SUBTRACTING LIABILITIES OF THE PLAN, WAS \$230,645,216 AS OF MAY 31, 2022 COMPARED TO \$238,876,316 AS OF JUNE 1, 2021. DURING THE PLAN YEAR THE PLAN EXPERIENCED A DECREASE IN ITS NET ASSETS OF \$8,231,100. THIS DECREASE INCLUDES UNREALIZED APPRECIATION OR DEPRECIATION IN THE VALUE OF PLAN ASSETS; THAT IS, THE DIFFERENCE BETWEEN THE VALUE OF THE PLAN'S ASSETS AT THE END OF THE YEAR AND THE VALUE OF THE ASSETS AT THE BEGINNING OF THE YEAR, OR THE COST OF ASSETS ACQUIRED DURING THE YEAR. THE PLAN HAD TOTAL INCOME OF \$7,043,427, INCLUDING EMPLOYER CONTRIBUTIONS OF \$16,117,494, GAINS OF \$5,113,890 FROM THE SALE OF ASSETS, EARNINGS FROM INVESTMENTS OF \$-14,216,885 AND OTHER INCOME OF \$28,928.
